Introduction

Eastway Primary School is a one form entry school for boys and girls age range from 2 - 11 years.

Eastway Primary School is committed to providing a fully accessible environment which values and includes all pupils, staff, parents and visitors regardless of their physical, spiritual, emotional, sensory and cultural needs.

Eastway Primary School recognise its duty under the Disability and Discrimination Act (DDA) 1995:

- not to treat disabled pupils less favourably for a reason related to their disability;
- to make reasonable adjustments for disabled pupils, so that they are not at a substantial disadvantage;
- to plan to increase access to education for disabled pupils.

This plan sets out the proposals of the Governing Body of the school to ensure access to education for disabled pupils in the three areas required by the planning duties in the DDA:

- increasing the extent to which disabled pupils can participate in the school curriculum;
- improving the environment of the school to increase the extent to which disabled pupils can take advantage of education and associated services;
- improving the delivery to disabled pupils of information, which is provided in writing for pupils who are not disabled.

Purpose of the Plan

This plan demonstrates how Eastway Primary School intends, over time, to increase the accessibility of our school for disabled pupils, staff, parents/carers and visitors.

Access to the physical environment

Eastway Primary School comprises of a large school building on one level with entrances through various classrooms and key stages. There have been a number of alterations to the school to allow access for all. Disabled car parking spaces are available in each car park and a number of ramps have been fitted to allow access to school and classrooms. See appendix 1 - school map
