Weekly Update

Dear Parents and Carers,

Under the current situation I feel that it is best to send a weekly letter to you with any updates and clear information. There has never been a more important time to make sure our communication is the best that it possibly can be. If you know of anyone who may struggle to access the letters electronically, may not follow us on social media or may not be receiving our app or text message updates, please do your best to support each other. I have attached some frequently asked questions and a grid for absence to support all your questions this week. I hope it helps. Please note that no parents/carers should be entering the school premises. This includes the waiting area in our Family Centre. Our staff and children must be protected. Visitors may only enter school with our consent and with prior arrangement and must not gather outside of school.

Staffing Update

As Mrs Billington is now in her third trimester of her pregnancy, it is not appropriate for her to be working in school in the current climate. She will continue to work from home and as much as I know we will all miss her, we must take action to protect her and Baby Billington as best we can.

Walk to School Challenge

There has never been a more important time to ensure that we are all fit and well. Walking to school or increasing our daily activity is vitally important. We are encouraging all children to walk, scoot or cycle to school. If you live far away, you can Ride and Stride, park far from school and walk the last bit. Teachers will be recording daily and tracking the progress for the children to be rewarded. Good luck!

Road Safety

We had a near miss incident this morning that could have been fatal. Cars should not be pulling up on pavements or pulling in to the staff car parks. The pavements are used for families and children to safely walk to school. Safety is paramount and is everyone's responsibility. We will have extra staff on duty to carefully monitor.

Before and After School Club

Our Early Risers Toast Club and Swashbucklers After School (S.A.S) are both now up and running smoothly. All places must strictly be booked and paid for in advance for us to manage our numbers attending. It is essential that you collect your child promptly fromm S.A.S by 5pm at the very latest. Toast Club will now operate from the extended school's hall, where SAS is. Access is still through the same gate, but children will enter via the smaller kitchen door by the Key Stage 1 Pirate Ship.

Feastway - School Canteen Reopening

In the next few weeks we will slowly and safely be reopening Feastway, our school canteen. Grab Bag lunches will continue next week but Years 3 to 6 will eat in the canteen. The following week we will reintroduce hot meals for these year groups, then from Monday 28th September Year 1 and 2 will go back in the canteen and be able to choose a hot meal and Reception Class and SCD1/2 from 5th October. We will monitor the situation very carefully so that we are keeping our bubbles separate and maintaining social distancing, if it becomes an issue we will revert back to lunches in class. School meals/Grab Bag lunches can be paid via ParentPay.







Frequently Asked Questions

Q. Can my child come to school if they have a cold?

A. Yes if your child does not have a symptom of COVID19 they can attend school. Snuffles, runny noses etc. are all fine. Always seek advice from your GP or 111 if you are unsure. The grid that we have produced on school absence will help make this clearer.

Q. What happens if someone in school tests positive for COVID?

A. Wirral LA and Public Health England will direct the school on the action to take. Mrs Morris and Mr Symonds, Chair of Governors will inform parents/carers and you will receive a letter explaining what will happen next. Children will need to continue remote learning daily if their bubble has to self-isolate and must not attend school for the set period of time.

Q. What if cases rise and Wirral have a local lockdown?

A. Primary Schools will remain open in any event of further local restrictions or lockdowns. If cases rise and we reach Tier 4, some children may have to complete remote learning from home.

Q. Why can't children bring in water bottles and packed lunch boxes?

A. We are assessing the risk involved in bringing things in and out of school and have taken the decision that if there are things that are not necessary, we will not be taking the risk. Lunches can be provided by school or disposable packed lunches sent from home and school provide daily drinks and snacks throughout the day.

Q. Why are some schools doing things differently?

A. Every school is different and all headteachers are using the guidance that we have been given to make the right choices for our own schools. Eastway is exceptionally lucky to have additional staff and with the space we have - outdoor areas, extra classrooms, halls, kitchens, toilets, wide corridors, different entrance and exit points etc. so we are able to do things that other schools may not be able to and vice versa.

Q. When will the canteen reopen?

A. Hot meals will start Monday 21st September- Key Stage 2, Monday 28th September- Key Stage 1 and Monday 5th October- Reception Class and SCD1/2. We will continually review this and only continue if we can maintain adequate distance and keep bubbles separate at lunchtime.

Q. Why do we have to go to different gates?

A. Our class bubbles are working well and we are carefully managing how they move around school so that they do not have contact with another bubble. This is to ensure safe social distancing and avoid any unnecessary disruption if we had a confirmed case in one bubble. We have thought very carefully about the gates and how they are managed and we thank you for supporting us by sticking to the gates you have been given so we can keep everyone safe.

Q. When will children get homework?

A. Our class teachers are busy preparing packs to be sent home next week and will explain everything in their Meet the Teacher presentation. Tasks are available online and children should be using TimesTable Rockstars and Bug Club daily to practise their key skills.
